# <u>Type of data processed, processing methods, purposes</u> of the processing for which personal data are intended and legal basis of the processing

Isoil may collect personal identifying data through its website, such as name, surname, email address, telephone number, through the channels on the "Contacts" page of the website. This information is used to answer questions and requests that are forwarded to Isoil through the contact channels on the site, and are never used for profiling activities.

This information may also be used for commercial purposes, such as sending promotional newsletters or emails, at the express indication and consent of the applicant. At any time, however, it is possible to stop sending such commercial communications by contacting the Data Controller.

The information collected is not shared with third-party companies for commercial purposes.

Isoil reserves the right to provide personal data in cases imposed by law or in legal or judicial proceedings.

The processing is carried out through mainly IT tools for the time strictly necessary to achieve the purposes for which the data were collected and, in any case, in accordance with the relevant regulatory provisions.

The Isoil website also makes use of COOKIES, small text files that are stored on the computer containing non-personal information regarding navigation within the site. Cookies stored by the Isoil website are exclusively technical cookies and have the following purposes:

- Customizing navigation. These cookies serve to recognize the user and store his browsing preferences (language, country, type of browser, etc...). They are intended to facilitate the navigation of the user.
- Traffic analysis on the site. Isoil uses Google Analytics. Google Analytics is an analytics service provided by Google. Google uses the collected data to track and examine how users use the site, to

provide statistical analysis, and to share it with other Google services. Google may use the collected data to contextualize and personalize advertisements within its proprietary networks. The personal data collected by Google Analytics are: Cookies and Data of Use of the Site. Data processing takes place in: USA. It is possible to view Google's privacy policy on the google.it.

No profiling COOKIES are used against users browsing the Isoil website.

Under no circumstances is Isoil processing this data, directly or indirectly, for the purpose of determining the identity of users. Isoil makes use of all necessary security measures to ensure the confidentiality of the collected data. Nevertheless, any method of transmitting data over the Internet or storing it can never be considered 100% secure. For this reason, Isoil cannot guarantee absolute safety.

The processing of the above data is carried out on the basis of a free and explicit provision of the Data Subject (e.g. in the case of use of the "Contacts" form) or the "consent" of users to the use of Isoil of traffic analysis cookies, manifested through the continuation of navigation through access to another area of the site or selection of an element of the same (for example, an image or link) thus entailing the provision of consent to the use of cookies. In any case, the user has the possibility to change their choices at any time by changing the settings of their browser.

#### Andrecipients or any categories of recipients of personal data

The Isoil website does not communicate or disseminate personal data of browsing users on its website.

#### Transfer of personal data to third countries

The Isolil website does not transfer any personal data of seafarers to EU countries or to non-EU third countries.

#### Retention period of personal data

#### Navigation data

Navigation data (e.g. IP addresses or domain names of computers used by users connecting to the site, addresses in Uniform Resource Identifier (URI) notation of the requested resources, the time of the request, the method used to submit the request to the server, the size of the file obtained in response, the numeric code indicating the status of the response given by the server (good end, error, etc.) and other parameters related to the operating system and the user's COMPUTER environment) are used for the purpose of obtaining anonymous statistical information about the use of the site and to check its correct functioning and are deleted immediately after processing.

#### Data voluntarily provided by the user

The optional, explicit and voluntary sending of e-mail to the addresses indicated on this site involves the subsequent acquisition of the sender's address, necessary to respond to requests, as well as any other personal data entered in the letter. Specific summary information will be progressively reported or displayed on the pages of the site prepared for particular services on request.

#### Cookies

The use of session cookies (which are not persistently stored on the user's computer and vanish with the closure of the browser) is strictly limited to the transmission of session identifiers (consisting of random numbers generated by the server) necessary to allow the safe and efficient exploration of the site. The session cookies used on this site avoid the use of other computer techniques potentially prejudicial to the confidentiality of users' browsing and do not allow the acquisition of personal identifying data of the user.

#### **Optionality of data**

Apart from what is specified for navigation data, the user is free to provide the personal data reported in the request forms or otherwise indicated in the Contacts area. Failure to provide them may make it impossible to obtain what is requested.

In all other cases the provision of data is free and optional.

#### Rights of data subjects

The data subjects to whom the personal data relate have the right at any time to obtain confirmation of the existence or not of the same data and to know its content and origin, verify its accuracy or request its integration or updating, or rectification as well as the right to complain to the Supervisory Authority.

They may also request the deletion, transformation into anonymous form or the blocking of data processed in violation of the law, as well as to oppose in any case, for legitimate reasons, their processing.
